Ticket Sales: ***Ticket Sales*** will be February 18-27; March 9-12; March 23-27; April 6-10. Only 150 tickets will be sold.

**Submit attached documents to the office for approval before purchasing tickets.** Tickets will be on sale during lunch and must be purchased by a SOAR High School student. Tickets will be \$95.00 per person or \$180.00 per couple for first two sales. Tickets will be \$100.00 per person or \$190.00 per couple the second two sales. NO REFUNDS.

**Pictures:** Pictures will be taken at the venue. Prices of picture packets will be available closer to the Prom date.

**SOAR High School Students:** Read this agreement packet and submit the attached documents (3) to the office for approval. If you would like to invite a guest, see below. Students will be required to comply with dress code regulations and all school policies set forth by SOAR High School and the Antelope Valley Union High School District. Students are required to have their school ID to board the bus. **Students are required to ride the bus to and from the venue. NO EXCEPTIONS.**

**Off Campus Guests:** Read the guest agreement packet and turn in the attached documents (4) and a copy of picture ID to the office for approval. A guest from outside the school must submit a guest application packet **prior** to purchase of a ticket. Only one guest is permitted per student. Guests who have been alternatively placed at any District school for discipline reasons (DWHS or Phoenix) may not be eligible to attend SOAR High School Prom. Guests must attend high school and/or be 15-20 years of age and must provide a valid form of ID as noted on the guest application. NO EXCEPTIONS! Guests will be required to comply with the dress code regulations and all school policies set forth by SOAR High School and the Antelope Valley Union High School District. GUESTS are required to have a picture ID to board the bus for prom. **GUESTS are required to ride the bus to and from the venue. NO EXCEPTIONS.**

The Junior Class at SOAR High School is sponsoring Prom 2020. They would like to remind you that school and district policies will be enforced and to thoroughly read and comply with the following:

## **Dress Code Policy**

- No slits or dresses shorter than the mid thigh will be allowed.
- No plunging necklines or backless dresses will be allowed.
- Bare midriffs are not allowed.
- Inappropriate dress will result in a student or guest not being allowed to board the bus for Prom 2020.

**\*We suggest you take a picture of the dress before you purchase the dress and have the office approve it.**

School personnel reserve the right to check all students entering the buses for Prom. Both school and event security will monitor activity throughout the evening.

## **BEHAVIOR EXPECTATIONS**

Students and guests agree to behave appropriately while on the buses and at Prom. Students must adhere to all SOAR High School and Antelope Valley Union High School District rules. Dancing or dancing in a manner that is inappropriate (lewd, sexually explicit, or offensive in nature) or dangerous to themselves or others will be subject to removal from Prom and will forfeit any refund. Removal from Prom will necessitate your parents providing transportation home from Prom. Money paid for Prom will NOT be refunded.

## **ELIGIBILITY REQUIREMENTS**

All of the following requirements must be met in order for a SOAR student to attend Prom:

- 11th and 12th grade students unless attending as a guest
- No off-campus suspensions during the months prior to Prom
- Positive Attendance (at the discretion of SOAR administration)
- No more than 1 unsatisfactory mark for citizenship in PowerSchool
- Good academic standing (at the discretion of SOAR administration)
